- As of 07/04/2022, Lenawee County has 26,975 positive cumulative cases:
 - o 208 total active cases
 - o 26,437 discontinued from isolation and improving
 - o 330 deaths
 - o 53.5% fully vaccinated
 - o 70% is vaccination rate goal

Collective Impact Core – Trauma & Resilience Common Agenda

2. Guiding Principle #2 – Transparency & Trustworthiness
 - a. Definition – Decisions are made with transparency and with the goal of building and maintaining trust among the people impacted.
 - b. LHN participants shared the following as components of building and transparent & trustworthy
 - i. Be up front when gathering or asking for information from consumers. Be transparent about how the information will be used.
 - ii. Have empathy & be honest
 - iii. Involve populations impacted in the decision-making process as much as possible.
- LHN participants shared examples of cultivating trustworthiness & transparency in their organization or in the community:
 - o Jackie Bradley, Lenawee Community Mental Health Authority, shared their organization developed a new strategic plan which included staff sessions and several components along the process to gather staff feedback, recommendations and to implement solutions in response.
 - o MSU-Extension shared that the Continuum of Care has cultivated relationships to incorporate representation from individual(s) with lived experience in their meetings.
3. Guiding Principle #3 – Peer Support and Mutual Self-Help:
 - a. Definition – Opportunities are created for acceptance, understanding, and validation from people with shared experiences.
 - b. The September LHN meeting will discuss examples of how Peer Support and Mutual Self-Help has been cultivated within our organizations or in the community.

- The organization has recently completed a \$2.5M endowment campaign, which is the first of its kind for the Club. Additionally, the Club is renovating spaces for high school and middle school education, new gymnasium, and new engaging opportunities for youth in Lenawee County.
- Boys & Girls Club of Lenawee has locations in Adrian and Hudson, MI and serves youth grades 1-12 in and surrounding Lenawee County.
- The organization provides a safe space for youth to engage in programming and youth development. They served over 1,000 youth in 2021 with 46% comprised of teens and 54% comprised of elementary youth.

Agency Updates & Emerging Issues

Vickie Pfeifer – Michigan State University Extension provided the following update(s):

- MSU-E is hosting Cooking Matters and grocery store tours with Meijer. Over the next two weeks, participants can engage in sessions touring various grocery store departments and learning skills to maximize the value of their dollar when grocery shopping for healthier food and meals.
- The last half hour of the tour is a \$10 grocery store challenge where participants can shop for items from each of the four food groups that make a healthy meal. Participants take the groceries at no cost so they may prepare the meal at home.

Jenny Culp – Family Medical Center of Michigan provided the following update(s):

- FMC is participating in National Health Center week and will have a pop-up food prescription clinic. They will also offer a COVID clinic to the community. Stop by their location or refer individuals in need of food access, COVID vaccine or other healthcare resources.

Cody Waters – Boys & Girls Club of Lenawee provided the following update(s):

- Boys & Girls Club is hosting a Community Family Day on August 12 for families to have fun and learn more about the Clubs services and programs.
- Cody confirmed he is willing to help navigate resources available at the State level if there are proposals or programs addressing health needs that need funding.

Juliana Moore – Care Pregnancy Center of Lenawee provided the following update(s):

- Julianna shared she is also active with the Lion's Club and that they have resources available for people without vision insurance to get related screenings and services. Please contact Julie if you have clients or individuals in need of services.

Martha York – Region 2 Area Agency on Aging provided the following update(s):

- Region 2 AAA has an Aging Master program starting next week and Chronic Pain PATH following.
- The group has received a Michigan Health Endowment Fund grant to partner with caregivers on physical activity promotion. They will be recruiting participants in September and an intake application flyer will be released soon. The program will serve 10 people in its first year and anticipates growing the program thereafter.

Riverview Terrace Residents Displaced & State of Emergency Updates:

- Residents are moving back to Lenawee soon. People are feeling relief knowing they are coming back to Lenawee/Adrian.
