### Collective Impact Core - Trauma & Resilience Common Agenda

- 3. Guiding Principle #4 Collaboration & Mutuality:
  - a. Definition Healing happens in relationship and in the meaningful sharing of power and decision-making.
  - b. LHN participants shared the following examples of Collaboration & Mutuality:
    - i. Laura Pipis shared that Lynne Punnett is leading an effort to secure housing for Riverview Terrace residents that have been displaced. In search of housing, Lynne included residents in the task force to explore suitable options and to contribute lived experience and perspective to the decision-making process.
    - ii. Martha York shared that the Matter of Balance program includes a section within the 4<sup>th</sup> session that dedicates time for participants to shared what they have gone through with their group. Participants have shared that it has helped to heal from trauma's they have experienced.
    - iii. Cari Rebottaro shared that working with Caregivers frequently encounters children that may have decision making power on behalf of their parent(s) but continue to include their parent(s) in the decision-making process so they are informed, empowered and can avoid trauma.
- 4. Guiding Principle #5 Empowerment, Voice, Choice
  - a. Definition Every person's experience is unique and requires and individualized approach. This builds on what individuals and communities have to offer, rather than responding to received deficits.
  - b. LHN participants will have an opportunity to share examples from their organization or personal experiences where Empowerment, Voice, and Choice were embraced to cultivate a trauma informed experience.

### Agency Spotlight Presentation:

- Laura Schultz Pipis from the United Way of Monroe & Lenawee Counties provided this month's spotlight presentation on their annual Health Check Events in Monroe & Lenawee Counties.
- Health Check event is held in Adrian twice a year and offers the community a 22 panel blood test for \$20 or no cost if individuals are experiencing financial strain.
- The event started 40 years ago in Monroe County and has expanded to Lenawee in recent years.
- The United Way partners with ProMedica Monroe Regional Hospital and ProMedica Charles and Virginia Hickman Hospital Lab departments to conduct the lab testing for all participants.
- The United Way also partners with the Lenawee County Health Department, MDHHS, First Presbyterian Church of Tecumseh and Adrian, Family Medical Center of Michigan, Area Agency on Aging, and many more to provide additional education, services, and health related screenings at the event.
