### III. Collective Impact Core Updates -

A. 6 Principles of Trauma-Informed Care: Empowerment, Voice, and Choice.

We shared the definition of the 6<sup>th</sup> principle of trauma-informed care: Empowerment, Voice, and Choice. This principle is about strengthening people's experience of choice and recognizes that everyone's experience is unique and requires an individualized approach. We build on strengths, rather than perceived deficits. Some examples of this principle that we shared include:

- Client Advisory Councils where clients come to agency board meetings and are involved in the choices our agencies make.
- Families get autonomy to choose childcare providers that meet their needs (location, budget, etc.).
- Working with clients to set goals that are important and meaningful for them.

We will discuss the final principle – Cultural, historical, and gender issues – next month!
